### **Spotlight: Jess Gromer**

Jess Gromer is currently the Program Officer for the John T. Vucurevich Foundation (JTVF) located in Rapid City, SD. Their mission is to invest in

organizations to enhance the quality of life for disadvantaged individuals and families with an emphasis on building prosperity from cradle to career. Her primary role is assessing the gaps and opportunities in the systems placing barriers to prevent families out of poverty. This includes investing in early learning, barriers to housing and childcare as well as assisting families and individuals in obtaining a living wage.

Jess is the lead staff person for the Early Learner work at JTVF. Prior to this position she has 15 years of nursing experience as a hospital staff nurse, a Regional Community Health Nurse for the SD Department of Health, and a Research Manager RN for the Center for Health Outcomes and Prevention Research for Sanford Research. Most of her career has been spent working in various roles within the maternal child field.

As a community health nurse, she worked in areas of health disparities and disease prevention, health education and case management. Her role with Sanford Research included working extensively with granting organizations and outcome management. There she managed project start-ups and shut-downs, project implementation, evaluation, grant reporting, and community relations. She worked with study partners from various geographical areas including New York, Boston and South Africa as well as multiple Northern Plains tribal partners from across North and South Dakota.

She has co-authored several publications related to her work within the Prenatal, Alcohol, Stillbirth and SIDS (PASS) Network. As a recent empty nester, she enjoys golfing with her husband and friends and spoiling their new lab puppy. She is very involved in their church and doing whatever she can to help her children navigate adulthood.

From data to cost modeling to policy option discussions, CED helps support a variety of strategies to ensure that working parents have child care choices in their communities.
